

It declared that the process through which Andra acquired ownership of the Lejuc forest is irregular and has given 4 months to sort out these irregularities before any further work can be done

Thessaloniki: In the beginning of April the Albatross a squatted house was brutally evicted at gun point. 13 people were arrested and 12 of them were released 32h later awaiting trial. One person was kept incarcerated for not having papers and could face 6 months in prison just for this. 2 arrestee were transferred to hospital during their time at the pig station. One for a severe head-wound sustained at the police station and the other cause the cops refused to allow them to take their medication for hours.
